A registrant must submit:-</p> <p>(a) only one Registration of Intent duly completed and signed by the registrant;</p> <p>(b) the Registration of Intent shall be accompanied with cashier order(s). The number of cashier order(s) shall be equal to the number of residential property(ies) which the registrant(s) intends to purchase as</p>

indicated in the Registration of Intent, but such number of residential property(ies) in any event shall not exceed two (2). Each cashier order shall be in the sum of HK\$150,000 and made payable to “WINSTON CHU & CO.”; and

- (c) a copy of the registrant’s H.K.I.D. Card(s) / Passport(s) and (if applicable) copy of Business Registration Certificate

to 86/F, International Commerce Centre, No.1 Austin Road West, Kowloon, Hong Kong (“designated venue”) from the date on which price list no.2 is made available to 18 April 2014 (both days inclusive) during office hours (i.e. from 2:00 p.m. to 8:00 p.m. on Monday to Friday and from 12:00 noon to 8:00 p.m. on Saturday, Sunday and Public Holiday, except for 18 April 2014 the office hours of which day should be from 11:00 a.m. to 6:00 p.m.). The closing time for submission of Registration of Intent will be 6:00 p.m. on 18 April 2014.

2. **If a registrant already holds a valid Registration of Intent and wishes participate in this balloting, the registrant (or his/her authorized person) must attend the designated venue during the said office hours before the closing time for submission of Registration of Intent referred to under paragraph 1 above to replace the said Registration of Intent with a new Registration of Intent. Otherwise, the registrant will be not eligible to participate in this balloting.** The registrant shall bring along his/her original H.K.I.D. Card(s) / Passport(s) (or a copy of the H.K.I.D Card(s)/Passport(s) of the registrant if the new Registration of Intent is submitted by an authorized person) and (if applicable) copy of Business Registration Certificate and the original receipt of the valid Registration of Intent, and (if applicable) a valid authorization letter and a copy of the H.K.I.D Card/Passport of the authorized person. The procedures set out in paragraph 1 above shall apply to the submission of new Registration of Intent. The registrant may at the same time change the number of residential property(ies) which the registrant intends to purchase as specified in the Registration of Intent.
3. Each registrant shall only be registered under one valid Registration of Intent. Duplicated registration of registrant will not be accepted. Late submission will not be accepted. The Registration of Intent is personal to the Registrant and shall not be transferable.
4. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies).
5. Balloting will take place in batches:
- (a) First round balloting (for dividing all registrants into one or more group(s))
- (i) The first round balloting will take place at 8:00 p.m. on 18 April 2014 at the designated venue for the purposes of dividing the registrants into one or more group(s).
- (ii) The Vendor reserves the right at any time, for the purposes of maintaining order at the designated venue and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of the first round balloting. Any changes to the time and date of the first round balloting will be posted at the designated venue and at the lobby on 3/F, International Commerce Centre, No.1 Austin Road West, Kowloon, Hong Kong (“the additional venue”). Registrants will not be notified separately of such changes.
- (iii) After the first round balloting, the registrants will be divided into one or more group(s) and the registrants in each group shall participate in the second round balloting which will take place in batches.
- (iv) The results of the first round balloting, including “registration number”, “division of group”, “check-in timeslot for each group” will be posted by the Vendor at the designated venue, after completion of the first round balloting. Registrants will not be separately notified of the ballot results.

(v) The Vendor shall not be responsible to the registrants for any error or omission contained in the ballot results.

(b) Second round balloting (for determining the order of priority of registrants in selecting and purchasing specified residential properties)

(i) The second round balloting of the group(s) of registrants will take place in batches at the designated venue at such time(s) as posted by the Vendor pursuant to paragraph 5(a)(iv) above. The Vendor reserves the right at any time, for the purposes of maintaining order at the venue and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of second round balloting. Any changes to the time and date of the second round balloting will be posted at the designated venue and the additional venue. Registrants will not be notified separately of such changes.

(ii) For the purpose of verification of identities, registrants shall attend the designated venue according to “check-in timeslot for each group” posted by the Vendor. In case the designated venue shall become insufficient to accommodate all the registrants, the Vendor may for safety reason direct the registrants to attend the additional venue by making announcement at the designated venue and the additional venue. Registrants must bring along his/her original H.K.I.D. Card(s) / Passport(s) and (if applicable) copy of Business Registration Certificate and the original receipt of the valid Registration of Intent. Registrants who arrive at the designated venue or (if directed by the Vendor) additional venue beyond “check-in timeslot for each group” shall not be eligible to participate in the second round balloting.

The results of the second round balloting, including “registration number” and “ballot result sequence” will be posted by the Vendor at the designated venue and the additional venue. Registrants will not be separately notified of the ballot results.

(iv) The Vendor shall not be responsible to the registrants for any error or omission contained in the ballot results.

6. Immediately after the second round balloting, the registrants shall proceed to select and purchase the specified residential properties which are still available at the time of selection in the order of priority according to the “ballot result sequence”. 7. If a registrant has successfully selected any of the specified residential properties, the registrant shall **personally** enter into a Preliminary Agreement for Sale and Purchase of the selected specified residential property(ies). Before signing the Preliminary Agreement for Sale and Purchase, the registrant may notify the Vendor on spot to add any person(s) who will be signing the Preliminary Agreement for Sale and Purchase, provided that:-
- (a) any additional person(s) must be a close relative of the registrant (i.e. spouse, parent, child, brother and sister);
 - (b) such close relative relationship has been proved to the Vendor's satisfaction; and
 - (c) the person(s) who will be signing the Preliminary Agreement for Sale and Purchase shall sign personally.

The Vendor reserves its absolute discretion to allow or disallow the registrant to add any person(s) to sign the Preliminary Agreement for Sale and Purchase.

8. If a registrant has not purchased any specified residential property or the number of specified residential property(ies) being purchased is less than the number of specified residential property(ies) which the registrant intends to purchase as indicated in the Registration of Intent, his/her unused cashier order(s) will be available for collection by the registrant (or his/her authorized person) at the designated venue during 20 April 2014 to 21 April 2014 (from 12:00 noon to 8:00 p.m.). The registrant must bring along the H.K.I.D. 有意購買任何指明住宅物業的人士(下稱「登記人」)須遵從下列程序：

1. 登記人須從價單編號 2 號提供的日期起至 2014 年 4 月 18 日(包括首尾兩日)於辦公時間內(即星期一至五下午 2 時至晚上 8 時及星期六、日及公眾假期中午 12 時至晚上 8 時，2014 年 4 月 18 日除外，當日之辦公時間為上午 11 時至下午 6 時)到香港九龍柯士甸道西 1 號環球貿易廣場 86 樓(下稱「指定會場」)，

- (a) 遞交一份已填妥及由登記人簽署的購樓意向登記；
